Dear Friends of Hear Indiana,

In 2018, the Hear Indiana Board of Directors, along with community leaders, drafted a robust new strategic plan for the organization through 2021! We are excited to share the results of this work with you. You probably saw our new mission, vision, and value statements on the cover of this annual report. Below, we've included our goals for the next three years. We hope you'll reach out to see how you can help us. Our job isn't done until all deaf or hard of hearing Hoosier children have an equal opportunity to succeed!

Hear Indiana will develop a community of people who advocate for Hear Indiana and its work.

At Hear Indiana we believe that even one child without language (whether visual or spoken), is one child too many. Without access to sound or a visual language at the earliest possible moment, a child with hearing loss will quickly fall behind his/her hearing peers. To be successful with Listening and Spoken Language (LSL), children need access to sound (via technology) and specialized therapy from a young age. Studies consistently demonstrate that most children with hearing loss can develop speaking, listening, and reading skills equal to or better than their hearing peers by the time they start first grade.

Hear Indiana will expand state funding for Listening and Spoken Language (LSL) services for children.

The impact of intervention is magnified as children complete a mainstream education and become contributing members of society. In fact, untreated hearing loss costs Indiana taxpayers \$1 million per child over the course of that individual's life. Approximately half of those dollars are spent on special education services.

Unfortunately, our state is failing countless numbers of these children (and their families) each year. Families move from one state agency to another (e.g., Dept. of Health, FSSA, DOE), with little preparation for the transition. Even if a family were able to successfully navigate Indiana's complex system, there are not enough qualified LSL providers available to serve them. If a child is lucky enough to find a qualified provider, s/he still needs access to high-quality, affordable technology, but the cost of hearing aids and cochlear implants is an additional barrier for many families.

Hear Indiana will expand the delivery of Listening and Spoken Language (LSL) services, support services, and hearing aids for children throughout Indiana.

For nearly 50 years, we have empowered and supported families of children who are deaf or hard of hearing; and for the past four years, we have offered audiology and speech language therapy to provide more children with access to LSL services, but there are countless more children we still need to reach! *continued on pg. 2...*

Hear Indiana will expand the role of private philanthropy to better serve Indiana's residents with hearing loss.



Hear Indiana Program Highlights



Lomont's Story

"Lomont was diagnosed with hearing loss, almost by accident, after he had an ear infection that failed two rounds of antibiotics. The ENT performed the audiogram, and then told us Lomont should probably ask to sit at the front of the classroom. No one at the ENT office talked to us about hearing aids or an FM (teacher microphone), and no one discussed an individualized education plan (IEP) at school.

After wrapping my head around the initial diagnosis, I realized that we needed help. Fortunately, we received a recommendation to contact Hear Indiana. Only through the help of Hear Indiana did we realize that Lomont needed hearing aids and how much Lomont was actually missing in his daily life. Ellyn, Hear Indiana's Family and Community Liaison, was integral in getting an FM through the public school system in order to have it Heritage Christian, our private school.



My first contact with the public school system was actually incredibly frustrating. The first woman who I spoke with told me that children like Lomont didn't qualify for FM systems and really didn't need them. Hear Indiana was able to provide the documentation needed to counter this attempt at denying services. In addition, Hear Indiana gave us the loaner FM that demonstrated to the public school system that it was an actual necessity for Lomont! Also, Ellyn personally attended the meeting to determine eligibility for Lomont. She knew exactly how to advocate for Lomont in such a professional but unfaltering way.

This past year was the absolute best year for Lomont scholastically. Before his hearing aids and FM, I was telling the teachers that Lomont was not learning the material at school, and that I was having to re-teach many basic concepts at home. Lomont now needs very little help at home, because he's not missing nearly as much during the school day. We hope that sharing Lomont's story can help others to see how amazing Hear Indiana is!"
